Pursuant to Plaintiffs' Motion for Second Disbursement of Settlement Funds to Claimants and supporting documents:

IT IS HEREBY ORDERED that:

1. Plaintiffs' Co-Lead Counsel and the Claims Administrator is authorized to disburse the payment of \$2,086,000.00 to pay approved Fixed Claim Class Members, as identified in Exhibit A to the Declaration of Justin L. Wind, from Associated Bank.
2. Plaintiffs' Co-Lead Counsel and the Claims Administrator is authorized to disburse the payment of \$502,449.72 to pay approved Documented Claim Class Members, as identified in Exhibit B to the Declaration of Justin L. Wind, from Associated Bank.
3. Plaintiffs' Co-Lead Counsel and the Claims Administrator is authorized to disburse the payment of \$1,101,103.80 to pay Documented Claim Class Members, as identified in Exhibit C to the Declaration of Justin L. Wind, who are approved to receive 90% or more of their requested amounts so long as these Class Members do not contest the

determination within 20 days of receipt of a claim determination letter from the Claims Administrator.
